

Lincoln Blvd. Task Force -- Public Safety Subcommittee -- March 4, 2013 Report

1) Common Ground -- CG community meetings were held on October 24th (30 days after the agency opened in its new location on Lincoln and Cedar) and on January 23rd, with the next meeting scheduled for March 5th. To reduce the overall number of neighborhood meetings, the idea of including the Common Ground reports in the FOSP and OPA Board meetings was suggested.

The CG "Good Neighbor Agreement" commitments include: participants signing a Participant Agreement, staff maintaining an Event Log, Closed Circuit TV, and nighttime security patrols by American Shield Security.

Artis Williams, SMDP Neighborhood Resource Officer for the Sunset Park and Pico neighborhoods, reported on October 23rd that there had been 4 crimes in the vicinity (including a robbery at the house adjoining the church on Cedar Street) but that the crimes were not attributable to Common Ground. At both meetings, he stated that the number and type of crimes reported in the area were consistent with existing crime rates.

At the January 23rd meeting, it was reported that Olympic High custodial staff had found a needle in their parking lot. Though needle exchange services are not provided at CG, the CG staff provided training to the school custodians on safe syringe disposal practices and also provided a disposal container.
