- ❑ **Roger Swanson** – Roger was appointed to the Board in 2010. He graduated from UC Berkeley with a BS in Business Administration and he earned his MBA from UCLA. Roger worked for Unocal and Xerox prior to forming his own management-consulting firm, which specialized in strategic planning, quality management and benchmarking. He has also served as an instructor and advisor for the UCLA Extension Business and Management Program. Roger retired in 2008.

In recent years Roger has actively supported Santa Monica's Land Use and Circulation Element (LUCE) with his attendance in workshops, letters to the Planning Department, as well as feedback to the City Council. Roger has been an active Ocean Park resident since 1998. He enjoys the community's friendly people and beach climate, and appreciates the neighborhood's proximity to Santa Monica's cultural attractions such as cuisine, art, and entertainment. In his spare time Roger enjoys bicycling, rollerblading, hiking, woodworking, cooking, photography, and travel.

- ❑ **Marcy Winograd** – Marcy, a former congressional candidate, teacher, and peace advocate, served on the OPA volunteer committee for the July 4, 2011, parade and on the Santa Monica Farmers' Market applicant evaluation committee. A founder of Progressive Democrats of Los Angeles, Marcy is an organizer at heart who recognizes the importance of our neighborhood association to support our local economy and safeguard our environment. While serving as a board member, one of Marcy's goals would be to promote block-by-block emergency preparedness in Ocean Park.

On the subject of development, Marcy has appealed to local council members to exercise caution in approving new traffic-heavy developments and to follow the framework of the Land Use and Circulation Element (LUCE)

On the subject of noise and air pollution at the Santa Monica Airport, Marcy wrote a pledge which local lawmakers and assembly candidates signed, vowing not to fly into or out of the Santa Monica Airport because of environmental hazards. Marcy has volunteered to participate on the "visioning" committee for the future of Santa Monica Airport and supports closing the flight schools - and ultimately the airport when the federal lease expires. She would like OPA members to play a leadership role in transforming the area to a community jewel.

With her years of experience in broadcast journalism, Marcy can occasionally be heard on KPFK guest-hosting "Connect the Dots" to discuss opportunities to resolve California's debt crisis and create a job-rich economy.

Last year, Marcy made one of the best moves in her life -- to 3rd and Ocean Park Blvd., where she lives with husband Buddy, a labor lawyer, and three rescue cats who love their garden of California natives.

- ❑ **Jim Lawson** – Jim has been a Los Angeles resident since his graduation from Brown University in 1979 where he majored in both Economics and Political Science. He has two children, one a recent graduate and the other still in college.

Jim is a two year resident of Ocean Park (3<sup>rd</sup> Street between Ashland and Marine) and he appreciates the feel and spirit of Santa Monica. He has been attending City Council meetings as well as various workshops and he would like to become more active in the community.
